



1. (ABBOT, John). GILBERT, Pamela. **John Abbot, Birds, Butterflies and Other Wonders**. London: Merrell Holberton, (1998), quarto, blue boards in decorative dust jacket. 128pp. First Edition. First in the series Art of Nature. Abbot was a pioneer artist who supplied collectors and other naturalists with specimens and exquisite paintings and drawings of birds, insects and plants. Some of the birds he painted are now extinct. He is relatively unknown in contrast to his contemporaries John James Audubon and Alexander Wilson. With 60 beautifully colored plates with Abbot's own comments, a Transcript of Manuscript 'Notes on my Life', a bibliography, and index. Very fine. (18456) \$40.00

Boston: Published by the Trustees [of the Boston Public Library], 1917, large octavo, printed blue wrappers. 271 pp. First Edition. "The John Adams Library includes nearly 3,000 volumes collected by Massachusetts native and the second President of the United States John Adams during his lifetime (1735-1826), as well as hundreds of additional volumes donated by friends and family members during the 19th century. The complete collection of printed books and pamphlets now totals more than 1,900 titles and 3,500 volumes.

John Adams took enormous pride in his library, and his lifelong passion for books and reading spanned his varied roles as university student, Boston lawyer, revolutionary, European diplomat, and President and citizen of the early American Republic. What makes the collection exceptional is Adams' scrupulous recording of thousands of interpretive and critical comments in handwritten notes throughout the margins of hundreds of his books. Not only are the volumes extensively annotated in Adams' own hand, but they are also often the repository of other personal objects, such as letters, bills of sale, and the autumnal pressed leaves of New England trees. Publication dates of the collection range from 1514 through the late 19th century. Holdings span the fields of classics, literature, history, politics, government, philosophy, religion, law, science, mathematics, medicine, agriculture, language and linguistics, economics, and travel. Many volumes in the collection are extremely rare, including a number of important first editions and heavily annotated works. One of the greatest private collections of its day, the John Adams Library remains the largest personal library collected in America during Adams' lifetime known to remain extant and intact." Each volume presents a vivid picture of the book trade and its part in the intellectual and cultural life of the age, including relations among authors, printers, and booksellers. Each entry consists of a header, the author, title and imprint of the book, a brief description of the binding, its provenance, and references, comparative material, literature, and notes when available. The headings also provide the place and date the book was bound and the name of the binder and first owner if known. Fully described and illustrated, the entries depict the kind of leather or covering material used, types of boards including paste board, pulp board, mill board, straw board, etc, spines, edges, doublures, leather joints, decorated end-papers, and the style of tooling. This second printing of David Pearson's *English Bookbinding Styles 1450-1800* includes a new introduction and a number of additional references and relevant points that have come to light since the book was first published in 2005. This well-regarded work provides guidance on recognizing and dating English bindings of the handpress period, from the middle of the fifteenth century to the beginning of the nineteenth. During this time, bookbinding was a handcrafted process and every binding made, however ordinary by the standards of its day, was a unique artifact. *English Bookbinding Styles* deals not only with the luxury end of the market (where so many binding studies have concentrated) but with the whole spectrum of binding options, the cheap and temporary with the permanent, the plain and middling, as well as the fine. In addition to providing practical help in placing particular bindings within their time and place, the book encourages a new approach to historic binding, concentrating not so much on binders and workshop attributes as on what a binding can tell us about previous owners and their approach to books. Well illustrated with over 250 photographs, the book fills a long-recognized gap in the literature and will be valued by librarians, book historians, booksellers, collectors, and anyone who deals with early books. Like the author's successful *Provenance* handbook, *English Bookbinding Styles* has become an essential reference work and a building block in the knowledge toolkit needed to develop a true understanding of books in their historical context. Published in two parts in 1799 and 1800, *The City of Philadelphia ...As it Appeared in the Year 1800* by William Birch was the first American color plate book to be published. During the mid 1890s, there was widespread use of the trichromatic half-tone process. This was quickly replaced with new mediums that dominated the twentieth century, providing the basis for this publication. Because production moved from hand-colored plate engravings and lithographs to the development of chromolithography, the nineteenth century shows the birth, rise, and eventual demise of methods of production in the culture of American printed books. Color in books represented luxury during the nineteenth century. Color was never cheap, and although technology made color plates available to a wider audience, the big color plate books were still only available to the rich because of their high cost. As the demand for color became stronger, publishers were more eager to supply it. To do this, it often meant hand finishing was replaced by mechanical work, and quality was therefore reduced. This exhibition takes a closer look at the world of lost processes and skills. This book traces the progression of production processes and the careers of some of the leading specialists. Aiming to show the diversity of color plate work among the leading titles, the exhibition displays highlights of the century and provides insight into the tastes and interests of those producing in the nineteenth



Drawing on legal, medical, religious, scientific and literary texts, and on how-to books on topics ranging from cooking, praying, and memorizing to socializing, surveying, and traveling, Bradin Cormack and Carla Mazzio explore how early books defined the conditions of their own use and in so doing imagined the social and theoretical significance of that use. The volume addresses the material dimensions of the book in terms of the knowledge systems that informed them, looking not only to printed features such as title pages, tables, indexes and illustrations but also to the marginalia and other marks of use that actual readers and users left in and on their books. The authors argue that when books reflect on the uses they anticipate or ask of their readers, they tend to theorize their own forms. *Book Use, Book Theory* offers a fascinating approach to the history of the book and the history of theory as it emerged from textual practice. 




Machines led to the closure of hundreds of handmade paper mills in the United Kingdom alone, but a few mills continued making paper by hand and against economic logic not only survived but flourished. The Green family's Hayle Mill in Maidstone, Kent, is one English mill that defied all the odds and continued to produce paper by hand, sheet by sheet, until production ceased in 1987. That it outlasted its competitors at a time of rapid industrial change and how it survived decades of political upheaval, economic collapse, and successive wars makes for a fascinating story. Chronicling six generations of the Green family of papermakers, who faced bankruptcy, amongst other trials and tribulations, before making a success of their business, this book also covers the history of British papermaking, the growth of the industry in and around Maidstone, once referred to as the country's "Paper City," as well as nineteenth-century production materials and techniques. Other subjects include the impact of the Crimean War and the call for unimaginable amounts of ammunition (cartridge) paper, the repeal of the "Tax on Knowledge," the exploitation of alternative fibers, such as straw and esparto grass, and the complicated security requirements of currency papers. As the nineteenth century drew to a close, a renewed interest in hand-crafted artifacts resulted in a growth in the market for artists papers made in the traditional manner. By the end of the First World War, the production of artists papers comprised 25% of Hayle Mill's business. Over the twentieth century, Hayle Mill steadily gained a reputation for its range of fine handmade papers for use by watercolorists, fine printers, calligraphers, and book and paper conservators. 


